






STEWARDSHIP REPORT

At Independence Hall in Philadelphia, the chair in which John Hancock sat as he convened the Continental Congress has a half sun carved into its back. Benjamin Franklin purportedly mused whether this sun—and allegorically the new nation being born—was rising or setting. He, ever the optimist, voted that the sun was rising.

The sun has set on another calendar year and a bright new year is rising.

What we at Children's Choice do in this new year will directly affect the lives of hundreds of children and their families. Each year, we are able to prepare half of the families of children discharged from us for reunification, restoring children to their birth families. The other half of our children who can be discharged are adopted or their kin achieve permanent legal custodianship of them. This year 399 children were positively discharged. That's a record to be proud of!

This year Children's Choice celebrates 25 years, a quarter century, of service. When we opened the doors in 1982, we hoped for 50 clients. We decided to hire a third person as a caseworker to augment the work of the two founders. Our work since then has been blessed. We opened an office in the State of Delaware in 1984 to work with specialized, general and mental health referrals, then in 1990 we began an office in New Jersey to handle adoptions and interstate transfers. We began to provide therapeutic foster care services in Maryland in 1991 and in 2004 we became licensed in Washington, D.C.

We have achieved another benchmark this year. Children's Choice now employs more than 200 staff and engages with 860 resource parents, who care for 1,117 children daily.

Our agency leads the field in quality of service, in comprehensiveness of paperwork, in relevance of training, in recruiting well-qualified people of faith and achieving permanencies for children.

To prepare for the future, we help to train undergraduate and graduate students from Widener University, Eastern University, Temple University, Rutgers University, Philadelphia Biblical University, Salisbury State College, Delaware Technical College, West Chester University, Chestnut Hill College, the University of Delaware, the University of Maryland, and the University of Pennsylvania.


The Children's Choice logo includes Franklin's rising sun because we believe in hope, the hope that changes events, plans and people.

We move into the coming year, full of plans, full of hope and the desire to have that hope shine into the lives of those we serve.




Goal 1: To increase the total number of children served: Seventy-two more children were served this year, increasing our total to 1,250 children with the greatest increase occurring in placement of children at the Specialized level of care. The next significant increase is the number of children at the Treatment/Mental Health level.




Goal 2: To expand kinship services: Thirteen fewer children were referred at the Kinship level of care. Twenty seven of the children at this level of care were discharged to permanent legal custodianship and forty four were reunited with birth families or kin.




Goal 3: To increase our services to medically fragile children: Thirteen children who entered Children's Choice with severe medical diagnoses were able, subsequent to medical treatment and medical foster parenting, to be moved to a less restrictive category of services.



Goal 4: To increase agency revenues: Due to new contracts and increases in current contracts in all states, Children's Choice revenues have increased 12%.




Goal 5: To increase the number of positive discharges: This goal was achieved as we positively discharged 399 children, 33 more than the previous year. A total of 186 children, 45 more than last year, were reunified with their birth parents, 44 went to live with kin, 136 were adopted and 33 achieved emancipation.



Goal 6: To increase staff retention rate.


Number of Employees by Years of Service Total Number of Employees: 186

COMMONWEALTH OF PENNSYLVANIA



One hundred and three children were adopted through Children's Choice in Pennsylvania this year. Seventeen of them were adopted through our Lewisburg, PA office, including a set of twins.

Eight of the children were over the age of 10 years; 9 were part of sibling groups adopted together.



Children's Choice attained the Performance Based contracting goal set by the Philadelphia Department of Human Services in achieving permanency for 157 Philadelphia children this year.



We achieved 366 permanencies in Pennsylvania!





In order to sustain familiar bonds, 144 sibling groups were placed in Pennsylvania. The groups ranged from 2 to 6 children.



One hundred and thirteen reunifications were accomplished in Pennsylvania this year.

Children's birthdays are celebrated with enthusiasm. Little Raiquan celebrated his first birthday this year with gifts and balloons.




Our medically fragile children have diagnoses including hydroencephaly, prune belly syndrome, cerebral palsy, encephalopathy, sickle cell anemia, myotonic dystrophy, HIV, seizure disorder, renal failure, cortical blindness and autism.

Their care requires gastric feedings, jejunostomy tubes, apnea monitors and central lines.




Over the past year, 30 children shown in the Heart Gallery have been adopted or placed in adoptive homes.



The growth has caused the Board to determine that quarterly meetings were no longer sufficient to accomplish the work to be done, so this year we began to hold bi-monthly meetings.

The parents of the Voice of Choice have undertaken some exciting activities! A contingent of VOC members attended the annual convention of the National Foster Parent's Association in Washington, DC. Board members were busy attending classes, and raising money for the scholarship fund by selling photo t-shirts and raffling quilts at the conference. We are planning for an exciting trip to Atlanta, GA for the next national conference in May of 2008.

The VOC continues to be an active participant in State and National Associations. President Regina Fike presented on the topic of "Foster Parent Association Leadership" at the 2007 Annual conference in Grantville, PA.

Our Scholarship Committee will meet in February to consider applications for the 2008 scholarship awards. Scholarships are available to any foster, kinship, adopted, or biological child of a Children's Choice family who is attending ANY post high school education. To date, we are thrilled to have awarded thousands of dollars in scholarships to some fantastic students!

Again this year, the VOC is proud to have sponsored the annual Santa's workshop for the children in each Children's Choice office so the children can purchase small gifts for their birth families and foster siblings. Throughout the year, the Voice of Choice has made endowments to the "Special Funds" of area offices so unique needs can be answered

In November, the VOC sponsored the annual Children's Choice Christmas Bazaar at International Plaza. Staff and families in each office donated "themed" gift baskets which were sold during a 3-day silent auction. Among the offerings were a beautiful Amish quilt, an Imaginarium train table, a gas grill and two children's bookcases. Parents worked in shifts to staff a bake sale table and photo t-shirt station. The hard work paid off! The Christmas Bazaar netted a profit of over \$2,500 for the Scholarship Fund! Thanks to families and staff for their support of this 'fun'draiser. We are looking forward to next year!
